

Several years ago, within half-a-dozen years, you will remember there was an appalling accident at Wollaston, in which a train of cars was wrecked in consequence of the negligence of a brakeman of a freight-train in not closing a switch upon the side-track. The passengers on board that train could get damages, but no man on the train, except he were a passenger, could get damages. The same principle is explained by further illustration. Here is a large manufactory, we will suppose the Pemberton Mills. Owing to the carelessness of somebody in the employ of the mill corporation, we will suppose, who constructed the building, it falls. Nobody can recover damages from the mill-owners except passers-by who may have been injured; employees cannot get damages if the accident occurred in consequence of the negligence of anybody in the employ of the Pemberton Mills in making the plans or designs. I do not now remember exactly the cause of the disaster, but this illustrates the principle of law. Again, if a staging is put up on any building in the process of construction, workmen are employed on that staging, and it falls; passers-by who are injured can get damages; but nobody who is at work on the staging can get damages, although the...
