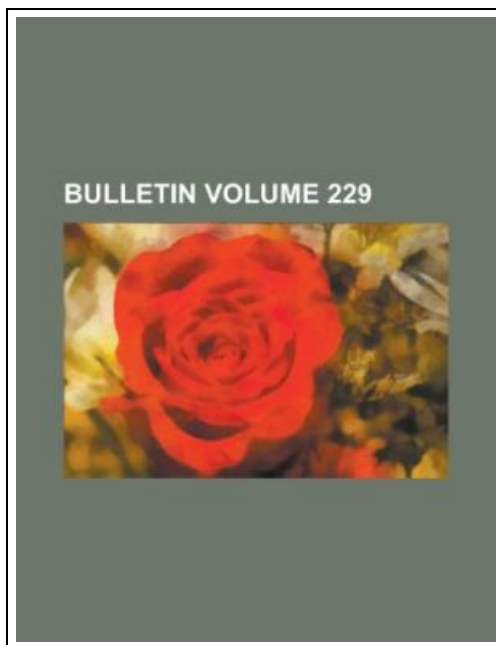

OMB First, OMB Bulletin No. 01-02, Audit Requirements for Federal Financial Statements, dated October 16, 2000, prescribes specific language auditors should use when reporting on an agency systems substantial compliance with FFMIA. Specifically, this guidance calls for auditors to provide negative assurance when reporting on an agency systems FFMIA compliance. Second, in a January 4, 2001, Memorandum, Revised Implementation Guidance for the Federal Financial Management Improvement Act, OMB provided guidance for agencies and auditors to use in assessing substantial compliance. The guidance describes the factors that should be considered in determining an agency's systems compliance with FFMIA. In addition, examples are provided in the guidance as to the types of indicators that should be used as a basis in assessing whether an agency's systems are in substantial compliance with each of the three FFMIA requirements.
